<p>Violation #36. Thermometers provided & accurate</p> <p>-Observed missing thermometer inside of both milk box refrigerators. Provide thermometer to correct reading.</p> <p>CODE REFERENCE: 64E-11.003(4). Thermometers must be calibrated to ensure accuracy in accordance with Rule requirements. Food thermometers scaled in Celsius (C) shall be accurate to plus or minus 1°C or in Fahrenheit (F), accurate to plus or minus 2°F. Food thermometers should be accessible for use by employees and have a probe size appropriate to the food item.</p>
<p>Violation #47. Food & non-food contact surfaces</p> <p>-Observed ice machine PC 1096563 not functioning at moment of inspection. PIC indicated that some type of oil from the motor it's getting inside of the ice machine and onto the ice. The work order number is #100086486</p> <p>-Observed the three door gasket broken and biological growth beneath of it located inside of refrigerator #3. Replace door gaskets. Clean and sanitize to prevent contamination.</p> <p>CODE REFERENCE: 64E-11.003(4). Equipment and utensils must be properly designed, constructed, and in good repair.</p>
<p>Violation #56. Ventilation & lighting</p> <p>-Observed light bulbs burned out inside of refrigerator #2, #3, and #5; and inside of freezer #3. Replace light bulb to provide lightning.</p> <p>-Observed missing light bulb and light fixture cover inside of refrigerator #4. Provide light bulb and light fixture cover.</p> <p>CODE REFERENCE: 64E-11.003(6)(a). Adequate exhaust ventilation hood systems in food prep and warewashing areas shall be provided and designed. 50 foot candles shall be at surfaces where employees work with food and 20 foot candles shall be at surfaces where food is provided to consumers.</p>
